STUDENT'S RIGHT TO CANCEL

STUDENT'S RIGHT TO CANCEL: You have the right to cancel the enrollment agreement, and obtain a refund of charges paid through attendance at the first class session //20, or the seventh day after enrollment, whichever is later. Cancellation occurs when you give written notice of cancellation at the institutionøs address. You can do this by mail, in person, or by fax. The notice, if mailed is effective by postmark date. This notice need not take any particular form; it needs only to state that you wish to cancel this agreement. If you cancel this agreement, Bentley-Forbes Security Training Academy, will refund any money that you paid, less any deductions for equipment not returned in new condition within 45 days after receipt of the notice.

PROCEDURE TO CANCEL: Cancellation occurs when you give written notice of cancellation to the Director of Student Services at **15720 Ventura Boulevard**, **#417**, **Encino**, **CA 91436 Phone: 800.455.7850**. You can do this by mail, email, in person. The notice, if mailed should be sent to 2625 Townsgate Road, Suite 330, Westlake Village, CA 91361 and is effective by postmark date. This notice need not take any particular form; it needs only to state that you wish to cancel.

WITHDRAWAL FROM COURSE: The institutional refund policy for students who have completed 60 percent or less of the course of instruction shall be a pro rata refund. After the end of the cancellation period, you have a right to terminate your studies at this school at any time, and you have the right to receive a refund for the part of the course or program you have paid for and did not receive. You have the right to withdraw from the course of instruction at any time. If you withdraw from the course of instruction at any time. If you withdraw from the course of instruction after the period allowed for cancellation, the school will remit a refund, less a registration fee, within 45 days following your withdrawal. You are obligated to pay only for educational services rendered and for unreturned books or equipment.
